New multi-technical contracting assignment in Västerås (Sweden)

Assemblin has secured a new contract from Peab for the design and installation of ventilation, electrical and automation solutions at Hitachi Energy's new facility in Västerås. The contract has an estimated total order value of SEK 160 million.

In connection with the construction of a new 40,000 m² office and production facility in Finnslätten, Västerås, with Peab as the main contractor, Assemblin has been assigned responsibility for the design and installation of ventilation, electricity and control systems.

The aim is for the building to be certified in accordance with the international environmental standard LEED Gold. The construction project commenced in 2025 and is scheduled to be completed in 2027.

"This is a very exciting assignment, imposing rigorous demands on quality, environmental impact, energy consumption and operational reliability. We are very pleased to have secured this assignment and to be working with Peab and other parties involved in contributing to an efficient process and a good end product.
